Where can I get my fire extinguisher serviced?

The fire extinguishers need to be serviced once a year or a new purchased and receipt submitted for your records. All fire extinguishers need to have a tag dated with the last time it was serviced. To find a fire extinguisher service center near you, look in your yellow pages. social worker will be looking for the expiration tag on all extinguishers. If extinguishers are new, social worker will be asking for the receipt.
