Where can I get my fire extinguisher serviced?

The fire extinguishers need to be serviced once a year or a new one must be purchased and the receipt for it submitted for your records. All fire extinguishers need to have a tag dated with the last time it was serviced. To find a fire extinguisher service center near you, look in your yellow pages or internet. The social worker visiting your home needs to look at the expiration tag on all extinguishers every year. If extinguishers are new provide the social worker a receipt.
